With reference to your email dated January 01, 2025, containing three queries regarding the Half yearly Submission of the Shareholding Pattern for the half year ended September 30, 2024, we hereby provide point-wise responses as follows:

Extract from the Mail:

This is in reference to the Shareholding pattern submission made by you for the quarter ended on September 30, 2024. It has been observed that the submission made by you as on September 30, 2024 is different from the submissions made by you in the SHP filed under Regulation 31(1)(a) of SEBI (LODR) Regulations, 2015 w.r.t. the following case/s:

1. There is a change in the number of Promoters.

Company's Response: It is submitted that at the time of filing the Shareholding Pattern for the halfyear ended September 30, 2024, the details of Promoters with zero holdings were not included. Based on our discussions with the NSE official, we have been advised to incorporate these details. Accordingly, we request you to kindly allow us to file the Revised Shareholding Pattern for the halfyear ended September 30, 2024.

2. Following entity is covered as promoter/promoter group in System Driven Disclosures (SDD) for Insider Trading (as per SEBI circular dated September 09, 2020), however not appearing as promoter/promoter group as per Table II of shareholding pattern (SHP) or vice-versa:
